In this document you will find, task instructions, offered use cases, submission instructions.

## 2 Task

You are a **Specialist in Process Automation and Optimization** within your organization. Your primary task is to evaluate potential solutions that can streamline and enhance the examination and certification processes for your company. As part of this mission, you have been assigned to assess the capabilities of the **YouTestMe application**, a cutting-edge platform designed to automate exam management, improve efficiency, and ensure compliance with industry standards.

Your role involves taking on the perspective of both a technical expert and a strategist. You will:

- 1. **Deep Dive into the Application**: Familiarize yourself with the platform's features and functionalities, understanding how they align with your organization's unique requirements.
- 2. **Simulate Real-World Use Cases**: Build scenarios based on your organization's needs, such as large-scale certifications, remote proctoring, or corporate training evaluations.

Use existing material you can find on our website (videos, articles), and optionally add custom text for better understanding. Include:

- Knowledge base links.
- Video tutorials.
- Custom instructions tailored to the use case.

#### 5. Prepare a PPT and Sales Pitch

## 3 Use Cases

# 3.1 U.S. Department of Education - Annual Certification Program

Exams are conducted in physical buildings using **100 computers per location**. Tasks include candidate registration, exam creation, proctoring, and generating detailed performance reports.

**Challenge**: Ensure seamless operations, adherence to government standards (e.g., ADA compliance), and accurate reporting to stakeholders.

# 3.2 Walmart - Weekly Cashier Certification
