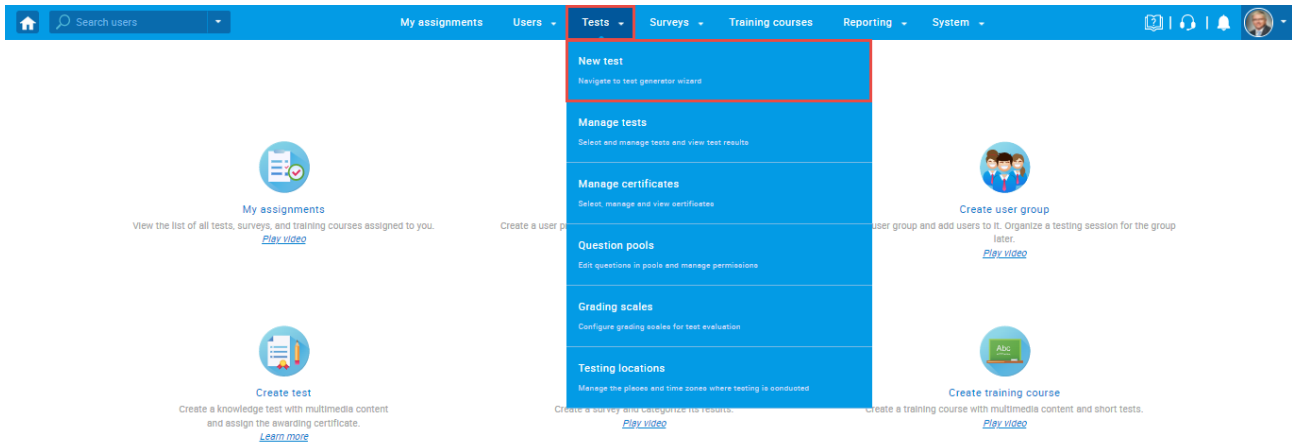

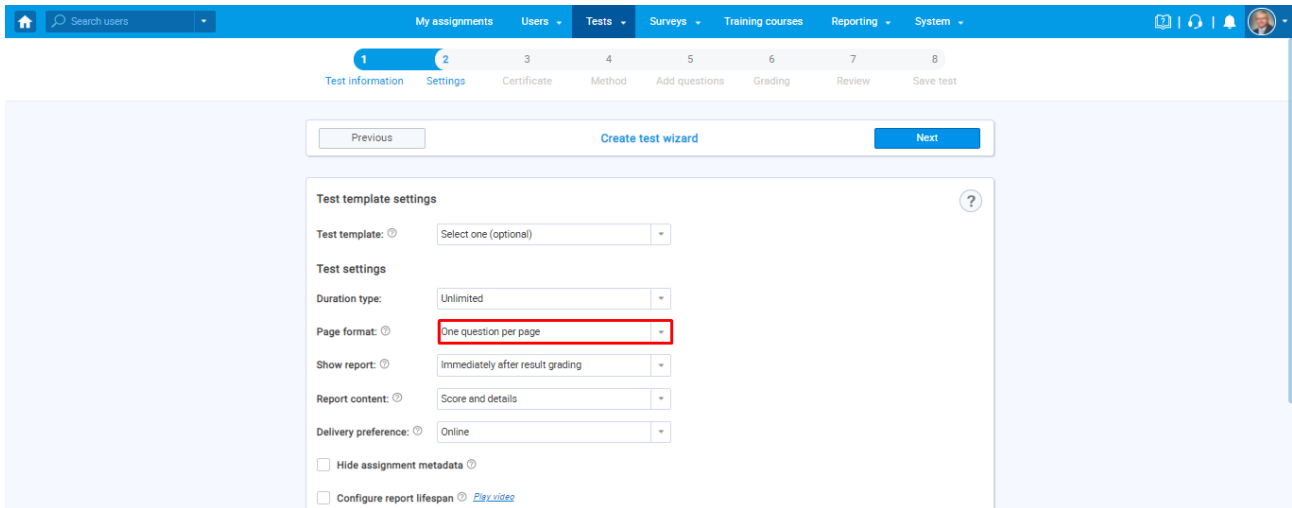
2.1 Creating a test

In the second step - "Settings," for the "Page format" option, choose "One question per page".



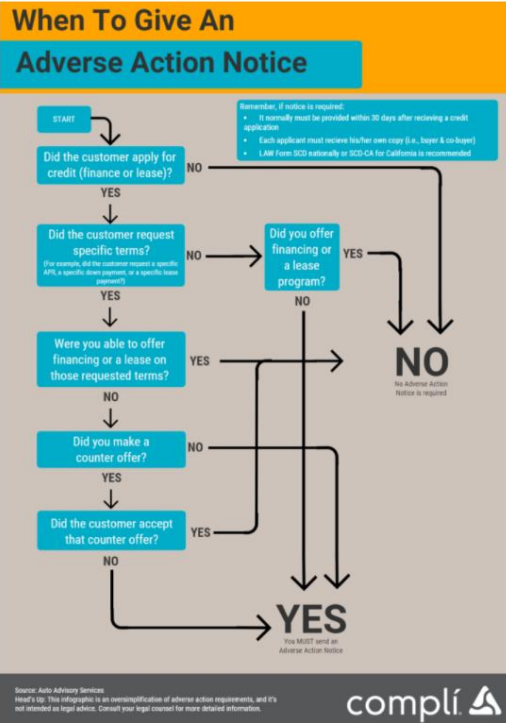

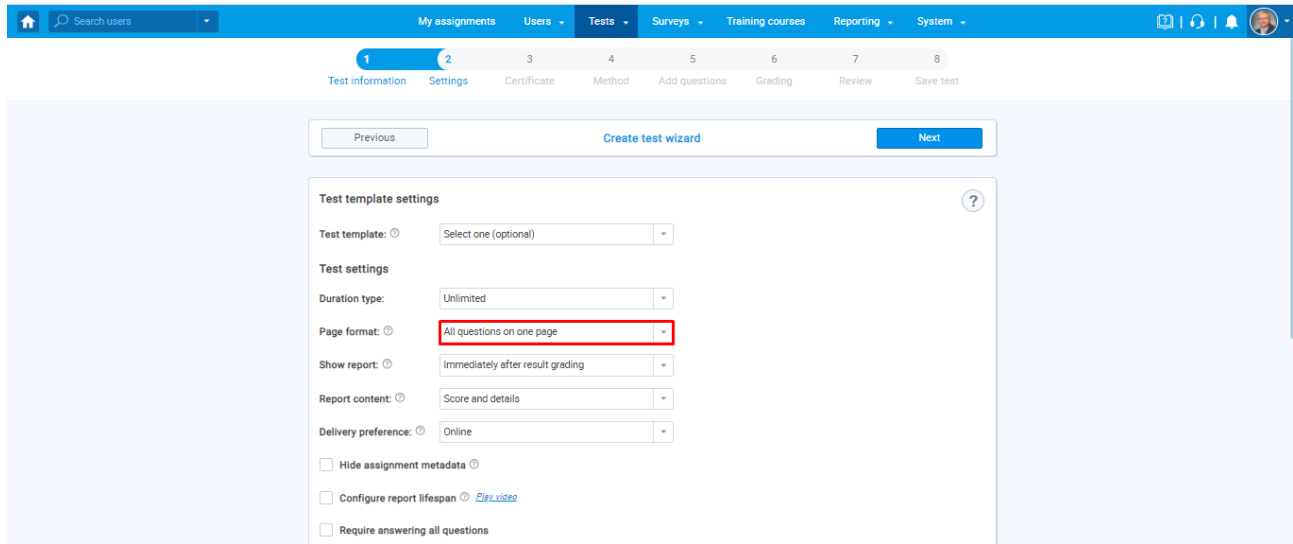
